SWIMMING POOL RULES AND REGULATIONS

The Wimmerton Swimming Pool will be operated under the following Rules and Regulations, subject to change without notice at the discretion of the Wimmerton Board of Directors or its designated management representative.

These rules and regulations are for the protection and benefits of all residents to assure safe and sanitary operation of the pool and other facilities, and to meet the requirements of all state and local laws pertaining to the operation of pools. Your cooperation in abiding by these conditions will afford a pleasant relaxation and recreation for all concerned. Parents are to inform their children of these Rules and Regulations and caution them to observe them and to obey the instructions of pool employees.

Any failure to comply with these rules and regulations shall be considered sufficient cause for any action deemed necessary by Management, including the barring of violators from use of this area.

1. Entrance to this area will be permitted by Members of the First Wimmerton Community and their guests. Guest passes may be purchased **ONLY** at the Pool Entrance. They are not transferable. The Pool Gate Attendant maintains a complete resident roster noting name and addresses for verification. ID may be required. All members must be in good standing with Home Owner Association Fees or you will be denied entrance.

2. THE QUALIFIED LIFEGUARD IS IN CHARGE OF THE POOL

He or she will be under direct supervision of the Management. However, all persons using the pool or the area around it do so at their own risk and are responsible for their own safety and actions. Owner, Management, its agents or any of its employees assume no responsibility for any action or injury in connection with such use. The Member covenants and agrees with First Wimmerton Community Association, Inc., its Management or agents for and in consideration for the use of the pool and pool facilities and other areas, and good and valuable consideration to make no claim whatsoever against Wimmerton, its Management, or its agents for or on account of any loss or damage to life, limb, or property sustained.

3. **GUEST PASSES.** Rates are subject to change and therefore will not be published in this document. Single day and weekly passes are available. There is no charge for children three years old or under.

On occasion, it may be necessary to restrict guest privileges due to overcrowding, especially on weekends or holidays. The Lifeguard will make this determination as needed. No refunds due to inclement weather will be given after 2:00 PM. Guests

18. NO PETS permitted in the pool area.
19. Admission may be denied to anyone with skin abrasions, colds, coughs, inflamed eyes, infections, or anyone wearing bandages
20. All persons use the facility at his/her own risk and in conformance with all rules and regulations. Any person may be barred from the pool or pool area at the discretion of the attendants in charge for violation of rules and regulations for any other reason which in the attendant's judgment constitutes a hazard to any person.
21. **THE LIFEGUARD IS RESPONSIBLE FOR THE STRICT ENFORCEMENT OF RULES.** He/she has the authorization to temporarily deprive any Member or Guest of the facility. A written statement is to be filed with the Management within twenty-four hours if such action is taken.

22. No abusive or profane language or breach of the peace will be tolerated.
23. First Aid Supplies may be obtained from the Lifeguard.
24. Expectorating or blowing of nose in the pool is prohibited.
25. Management reserves the right to refuse entry or deny pool privileges to anyone at its sole discretion.
26. Entrance to the pool area is through the Main Gate only. Entrance by any other means is subject to immediate expulsion and the violator will be barred from admission for no less than twenty-four hours.

These rules and regulations become a part of each Member's lease or deed as set forth in the covenants. They may be revised and amended at any time at the discretion of Management of the Board of Directors. Failure to comply with any of the foregoing rules and regulations will result in the violator being barred from the use of the pool facilities. A copy of the current rules and regulations are available for review at the Pool Gate Attendant's station. All persons entering the pool area are assumed to understand these rules and regulations, and agree to comply with them.

will not be permitted to use the pool unless accompanied by a Member and shall at times be deemed to be the guest of the Member and not of Wimmerton.

4. Members are fully responsible for the actions and safety of their guests.
5. Members agree to save harmless Wimmerton, its Management, and agents from any and all harm, liability claims, and actions of any nature whatsoever by any guests or guests of Members growing out of the use of the swimming pool or area.
6. The cost of any property damage by Member or Guest of the Member will be charged to the Member.
7. Management will not be responsible for loss or damage to any personal property of any kind.
8. The use of the pool and pool area is permissive only and may be withheld or terminated at the discretion of the Management.
9. The pool may be closed at any time at the discretion of the Lifeguard or Management.
10. All bathers **MUST** shower before entering the pool.
11. Hair curlers or similar apparatus is not permitted in the pool.
12. Cut-off jeans, gym trunks, or other garments not specifically designed for swimming pool use are **NOT** permitted in the pool.
13. Children under the age of twelve (12) must be accompanied by a responsible person for admission to the pool area. Use of the pool by anyone under sixteen (16) years of age may be restricted or denied until her/she can comply with the minimum standards for water safety as determined by the Lifeguard.
14. The pool will be closed during the inclement weather or when the temperature is not expected to reach 70 degrees during the day.
15. Running, pushing, wrestling, ball playing, or causing undue disturbances or noise in or about the pool area will not be permitted.
16. No personal property may be stored in or around the pool area or the Community Building.
17. No rafts, inner tubes, or play equipment may be used in the pool. This does not include instructional aides used in conjunction with training under the direction of qualified instructors and in restricted areas.
